

Conditions for taking part in the “Erasmus+ Diary” competition

1. General information

- (1) The organiser of this competition is the OeAD (Österreichische Austauschdienst)-Gesellschaft mit beschränkter Haftung – Austrian Agency for International Cooperation in Education and Research (OeAD-GmbH), Ebendorferstrasse 7, 1010 Vienna. The OeAD-GmbH is responsible for the organisation, handling, and the provision and distribution of the prizes.
- (2) By taking part in the competition the participant agrees with the following conditions of participation.
- (3) The OeAD-GmbH reserves the right to change the conditions of participation in the competition for important reasons or to terminate the competition prematurely. In such case the OeAD-GmbH will inform all participants.
- (4) The judges’ decision is final. Prizes are not redeemable for cash.

2. Eligibility

- (1) Only natural persons who are completing a stay abroad (mobility or project meeting) sponsored by Erasmus+ during the competition period (April 29th to November 10th, 2019) are entitled to take part. The sending educational institution must be based in Austria. Persons under the age of 18 must submit a signed declaration of consent from their legal guardians when registering in order to be eligible to take part.
- (2) Multiple participation is not permitted.
- (3) Participation under another person’s name or under a false name is not permitted (exception: Facebook profiles do not have to match the participant’s actual name). The OeAD-GmbH reserves the right to exclude participants from the competition if they do not comply with the conditions of participation or try to influence the competition in an unfair way. In particular, participants whose contributions contain offensive or illegal content or serve commercial purposes can be excluded.
- (4) Employees and other persons working for the OeAD-GmbH are excluded from taking part.

3. Procedure

- (1) Participation in the competition is only possible during the period from April 29th to November 10th, 2019, 23:59.
- (2) In order to take part you have to publish your diary entries in the Erasmus+ diary (<https://erasmusplus.europa.or.at/login/facebook>), which is integrated in the OeAD-GmbH’s Facebook page “Erasmus+ Education Austria”, regularly during the term of your stay abroad.

If you are staying for less than one week you have to publish at least two diary entries. If you are staying for longer than one week, you have to publish one diary entry per week on average.

(3) When putting photos online you are confirming that you have the unrestricted right of use (including the right to transfer/pass on this right of use) of these photos and that the photos may be published free of charge on the OeAD-GmbH's website and social media channels as well as in the OeAD-GmbH's print publications without the author being named (=author's express consent to publication in the named media without additional claim to remuneration and without the author needing to be named).

The participants will transfer the right to use the diary entries and the included photos in full, not exclusively but spatially and temporally unrestrictedly, to the OeAD-GmbH for publication in the OeAD-GmbH's print and web media without separate remuneration claim and, as far as the photos are concerned, without the author having to be named.

The participant further confirms that the photos do not infringe the rights of third parties, in particular copyrights and/or moral rights (= that the photos do not contain any protected content such as logos or photos of other persons or – if this is the case – that he/she has the right to use the protected content or the consent of all persons depicted).

The OeAD-GmbH reserves the right to delete postings and comments at any time without giving reasons.

If claims are asserted by the author of a photo due to violation of his/her copyright or by third parties due to violation of their personality rights, copyrights or other exclusive rights, such as work usage fees or other claims for damages, the participant shall indemnify and hold the OeAD-GmbH harmless in this respect, i.e. reimburse the OeAD-GmbH for all costs associated with the assertion of these claims.

(4) The OeAD-GmbH will select the best diarists and present them with a prize within the framework of the "Erasmus+ Awards" event.

(5) The selection of the winners will take place in camera.

4. Acceptance of the award

(1) The winner will be informed by the OeAD-GmbH by e-mail, to which he/she has to reply, stating his/her address, telephone number, date of birth and full name. Only after having been notified in writing about having won the prize will the winner have a claim to the prize.

(2) The winner agrees that excerpts or the whole of his/her diary and any photos therein will be published including his/her first name and initial of his/her surname on the OeAD-GmbH's website and social media channels as well as in the OeAD-GmbH's print publications.

(3) The winner will be presented with the prize in person at the Erasmus+ Award on December 3rd, 2019. If he/she does not accept the prize, the entitlement to the prize will be forfeited and the OeAD-GmbH will, time permitting, draw another prize winner among the remaining participants at its own discretion. The original winner will no longer be entitled to his/her prize after the deadline has expired.

(4) Participants are responsible for making sure that the data they provide is correct.

5. Liability

The OeAD-GmbH assumes no liability for the violation of moral rights or copyrights of third parties that may be committed by the participant's diary entries or published photos. If third parties assert such rights, the participant shall indemnify and hold the OeAD-GmbH harmless in this respect.

6. Use of data

The participants acknowledge that the personal data collected in connection with the organisation and handling of the competition will be entered, stored and processed by the OeAD-GmbH as the responsible organisation in accordance with the GDPR and on the basis of the valid legal provisions.

Data processing is carried out on the basis of Article 6 para 1 lit a) of the GDPR and on the basis of the participant's consent by voluntarily registering for the "Erasmus+Diary" competition and confirming the conditions of participation for the purpose of conducting and handling the "Erasmus+Diary" competition during the period from April 29th to November 10th, 2019.

The participant – or the parent or legal guardian of a minor participant – may revoke this consent at any time.

A revocation means that the participant **can no longer take part in the competition** and we will not process the participant's data from that point in time for the above-mentioned purposes anymore and delete the diary entries.

After having accepted the prize it is no longer possible to object to the use of your data for the above-mentioned purpose.

In the context of electronic data processing the OeAD-GmbH commissions IT service providers (contract processors), who may gain access to personal data of the participants in

the course of their activities, insofar as they require the data for carrying out their services. These service providers have been obligated by the OeAD-GmbH to take adequate technical and organisational measures to ensure the protection of the data. These service providers are not permitted to pass on the participants' data (except in cases where this is required by the law).

The participants have the right towards the OeAD-GmbH to get information about their processed personal data at any time as well as the right to have their data corrected. Provided that there is no legal retention obligation or other legal basis for the processing of your data, you have the right to have this data deleted and to object to the processing.
